Driving directions from Jackson Hole Airport (airport code = JAC):

It takes approximately 2 hours to drive from Jackson Hole Airport to Thunderhead Ranch.

After exiting the Jackson Hole Airport, turn left and drive north on Hwy 26/89/189 about 21 miles to Moran Junction. At Moran Junction, bear right and drive east/southeast on Hwy 26/287 about 55 miles to Dubois. (Note: Near the east side of Dubois, Hwy 26/287 takes a sharp right turn; drive slowly.)

From Dubois, drive southeast on Hwy 26/287 about 10.5 miles. Turn left (north) onto County Road 277/East Fork Road. (Note: You will see a Trial Lawyers College sign at the intersection of Hwy 26/287 and County Road 277/East Fork Road.)

After driving north on County Road 277/East Fork Road about 10 miles, you will drop down a slight hill and see an enormous wooden sign (painted brown and white) that says "Trial Lawyers College – Thunderhead Ranch – Registered Simmentals." Turn right (east), cross a bridge and continue driving. You will pass two brown homes on your right. Do not stop. Instead, continue driving east along a buck and rail fence. At the end of the fence, turn right (south) and drive 75 yards to the second driveway. Turn right (west) and drive 100 yards to the parking area in front of the cookhouse/office. You made it!

Driving directions from Riverton Regional Airport (airport code = RIW):

It takes approximately 1.5 hours to drive from Riverton Regional Airport to Thunderhead Ranch.

From the west edge of Riverton, drive northwest on Hwy 26/287 about 68 miles. Turn right (north) onto County Road 277/East Fork Road. (Note: You will see a Trial Lawyers College sign at the intersection of Hwy 26/287 and County Road 277/East Fork Road.)

After driving north on County Road 277/East Fork Road about 10 miles, you will drop down a slight hill and see an enormous wooden sign (painted brown and white) that says "Trial Lawyers College – Thunderhead Ranch – Registered Simmentals." Turn right (east), cross a bridge and continue driving. You will pass two brown homes on your right. Do not stop. Instead, continue driving east along a buck and rail fence.
